- 2. Evidence of working for social justice, educational equity, and multilingualism in schools and other public settings.
- 3. Evidence of strong background in research methodology.
- 4. Extensive experience as a Spanish speaker and bilingual use of Spanish and English.
- 5. Interest in promoting dual language/bilingual education locally, regionally, and/or nationally
